

# COZY CAT LODGE

## Boarding Contract

1. This is a healthy-cat lodge only. Sick or injured pets should be boarded under a vet's care. Sick or injured pets are not permitted due to the health of our other guests.
2. All vaccinations must be current within one year. WE REQUIRE A COPY OF VACCINATION VERIFICATION ON OR BEFORE CHECK-IN. Complete immunization of all our guests provides a healthy environment for your pet.
3. Cats MUST be flea, tick, other parasite and ringworm free. Cozy Cat Lodge is a flea-free environment, but due to the unpredictability of these critters we cannot guarantee that your pet will be returned without fleas. To prevent flea infestation in the Lodge and on your cat, please administer flea control medication *two days before* your cat checks in. If fleas are detected on your cat, we will apply a flea medication to protect our other guests. THERE WILL BE A \$15 CHARGE FOR APPLICATION.
4. If your cat requires medical attention, we will contact your veterinarian whenever possible. If circumstances require more immediate action, we will contact a veterinarian that is close to the Lodge.
5. If there is a life threatening situation or emergency with your cat and we are unable to contact you, the veterinarian will have authority to make all medical decisions, including euthanasia, based on his/her diagnosis and the welfare of your cat. The veterinarian, veterinary clinic and the Cozy Cat Lodge will not be liable.
6. Due to our other guests' comfort and insurance risks we cannot accept any pet judged to be biting or aggressive.
7. A professional blend of nutritious food is available at Cozy Cat Lodge. We highly suggest bringing your cat's favorite food to prevent digestion problems.
8. We will properly dispense medications, but they must be specifically labeled with your pet's name and instructions.
9. There is a 3-day minimum charge. A \$25.00 deposit is required with paperwork to secure a space. For boarding 14 or more days there will be a 50% deposit per cat.
10. Owner agrees to pay all costs and charges for all services per rate schedule, including all veterinary cost if such services are required and at the sole discretion of the Cozy Cat Lodge. All charges incurred shall be paid and cleared before pet(s) leave the Lodge.
11. Please understand that even with the best possible care some pets will not enjoy being away from home. Some may not eat well, may be nervous and stressed, resulting in a loss of weight, upset stomach, or diarrhea. We will use all reasonable precautions to assure your pet's health and safekeeping but cannot be held responsible for unforeseen circumstances.
12. Every reasonable care shall be exercised to prevent injury, illness, escape, or death. Owner will completely absolve Cozy Cat Lodge and its agents of damage and responsibility while pet(s) are in the care of the Lodge.
13. Abandoned animals will become the property of Cozy Cat Lodge to do with as we decide best.
